#### **SEARCH**

Operation used to search globally on business name, address and by size, age and whether operating

#### **MATCH**

To find an organisation using business name, address, business ID or DUNS Number

#### VERIFICATION (FIRMOGRAPHICS)

Used to request the DCP\_PREM data product. The service has other data packets but these are not enabled for the Compliance offering

#### SCREENING DATA (KYC)

Used to request the custom data product behind the Know Your Customer/Compliance Section of the Onboard Compliance Report

DNBProductID = KYC

#### GLOBAL BENEFICIAL OWNERSHIP

Used to request the individual shareholders of an organisation

DNBProductID = GBO

#### SIMPLE OWNERSHIP

Used to request the corporate owners of an organisation DNBProductID = SMPL\_OWNSHP

#### **GLOBAL FAMILY TREE**

Used to obtain the Famiy Tree

#### PRODUCT AVAILABILITY

List of products available on an entity

#### REPORT ORDER

Used to obtain the Comprehensive and Business Information Reports which are available in PDF and HTML formats (not data) and which constitute the remainder of the Onboard Compliance Report.

#### COMPANY DOCUMENT IMAGE LIST

Uses ListCompanyPublicDocument Service within the Product Catalog Service.

#### COMPANY DOCUMENT IMAGE ORDER

Uses OrderCompanyPublicDocument Service within the Report Product Service.

#### **INVESTIGATIONS**

Used to raise an investigation on an organisation

#### REFERENCE DATA

Provides look-ups, cross works and translations of codified data

## ARCHIVE OF PREVIOUSLY ORDERED PRODUCTS

Used to view list of data products and reports retrieved in the last 120 days and to review the status of investigations
